

## **Articulation Agreement with Guaranteed Admission**

### **Lake Region State College and Minot State University**

**Introduction:** The articulation agreement with guaranteed admission formally recognizes that Minot State University (hereinafter MiSU) and Lake Region State College (hereinafter LRSC) are educational institutions that agree to work together to provide nursing education opportunities for their students. This agreement confirms that all students admitted into the LRSC Associate Degree Nursing (ADN) Program will be given the additional option of guaranteed admission into the MiSU Online Bachelor of Science in Nursing (BSN) Completion Program, with the condition that all MiSU Admissions and BSN Completion Program requirements are met. This partnership emphasizes the importance of a well-educated nursing workforce, which includes BSN-prepared nurses.

**Purpose:** The purpose of this agreement is to outline the process for a seamless nursing education pathway from LRSC to MiSU. Students will earn an ADN at LRSC with an Associate of Applied Science (A.A.S.) degree and be allowed guaranteed admission to MiSU to earn a BSN Degree.

In the final semester of the student's ADN program at LRSC, conditional admission to the BSN Completion Program will be granted, pending the successful completion of their ADN, (A.A.S.) degree at LRSC, successfully passing their NCLEX-RN® licensure exam, and meeting all MiSU admissions and BSN Completion Program requirements.

It is understood and agreed that courses completed at LRSC are considered equally transferable to MiSU's Online BSN Completion Program and NDUS GERTA applies to the guaranteed admission agreement. Students with an Associate of Arts (A.A.), Association of Science (A.S.), or a bachelor's degree from an accredited degree-granting institution would be considered general education complete.

Through this partnership, students will be provided:

1. A clearly defined, and easily understood pathway from the LRSC ADN Program through the MiSU BSN Completion Program.
2. Continued curriculum alignment between LRSC and MiSU nursing programs.
3. Early and coordinated advising between institutions and students to ensure timely completion.
4. Early admission, to meet the February 15 deadline for MiSU general and nursing scholarships.
5. A complete review of transcripts to assure credit for past academic coursework with appropriate course substitutions and equivalencies.

#### **Guaranteed Admission Process:**

1. LRSC ADN students will be given LRSC and MiSU BSN Completion Program guaranteed admission information from their LRSC nursing advisor in the first semester of their ADN program.
2. Students will be given the option to be assigned a MiSU BSN Completion Program advisor as early as the first semester of their ADN program.
3. [Apply for admission to MiSU](#) in the Fall semester of the LRSC ADN year and meet all MiSU admission requirements.

4. To ensure students meet the MiSU scholarship application deadline, complete the online [MiSU BSN Completion Program application](#) by February 1 in the final semester of the LRSC ADN program and meet all [BSN Completion Program requirements](#).
5. After being accepted to the BSN Completion Program, complete the [MiSU general and nursing scholarship application](#) by February 15.

\* NCLEX- RN Credit: MiSU to post 35 credits to the transcript for NCLEX-RN exam credit upon graduation semester to meet [MiSU graduation requirement](#) of 60 credits at a 4-year institution.

### **Joint Obligations:**

MiSU faculty or staff members will visit LRSC ADN Program at Devils Lake, ND at least once a year to promote the MiSU BSN Completion Program and guaranteed admission agreement between MiSU and LRSC, advise prospective students, and collaborate with LRSC nursing advisors and instructors.

MiSU faculty advisors will be available to LRSC nursing students throughout their ADN program at LRSC.

MiSU faculty or staff members will be responsible for providing LRSC with MiSU BSN Completion Program and guaranteed admission information materials.

LRSC will provide their ADN students with guaranteed admission information in the first semester of their ADN program and make materials available upon student request.

LRSC will provide their ADN students with contact information for BSN Completion Program advising.


Minot State University and Lake Region State College will exchange data and documents as agreed that will contribute to the maintenance and improvement of the transfer agreements and promote effective cooperation between the two institutions.

### **Monitoring, Review, and Agreement Longevity:**

Both parties shall each name a principal contact person/office to the partnership program; further, these individuals (or department representatives) will be responsible for coordination related to the partnership program and the flow of communication within their institution. All agreements must be reviewed for updates with the signatures of representatives or delegates at least every five years.

This articulation agreement with guaranteed admission may be discontinued by either educational partner by submitting written notification to the other partner one year before the identified cancellation date to protect all students transferring between these institutions.


